

# Paid internships in child care centres

## Graduate from your Diploma and potentially gain sponsorship in a child care centre through a Training & Research Visa (TRV)

An international student who graduates with a CHC50908 Diploma of Children's Services (Early Childhood Education and Care) has the opportunity to seek a very desirable sponsorship with a child care centre under the Australian Training & Research Visa (TRV) program.

Advantages include the opportunity to work full time, gaining valuable work experience while earning a full time wage. The program could widen your career options.

### What is a Training & Research Visa (TRV)?

The visa allows suitably-qualified people to train and improve their skills and knowledge with on-the-job training on a temporary basis. The job role is usually that of a new graduate training towards a managerial position. You must already have graduated at diploma level (and have all your documents ready) before applying for the visa. The length of time this visa is usually granted for is 14 months. This was previously known as an Occupational Trainee Visa (OTV).

### Requirements

To apply for TRV you will need the following:

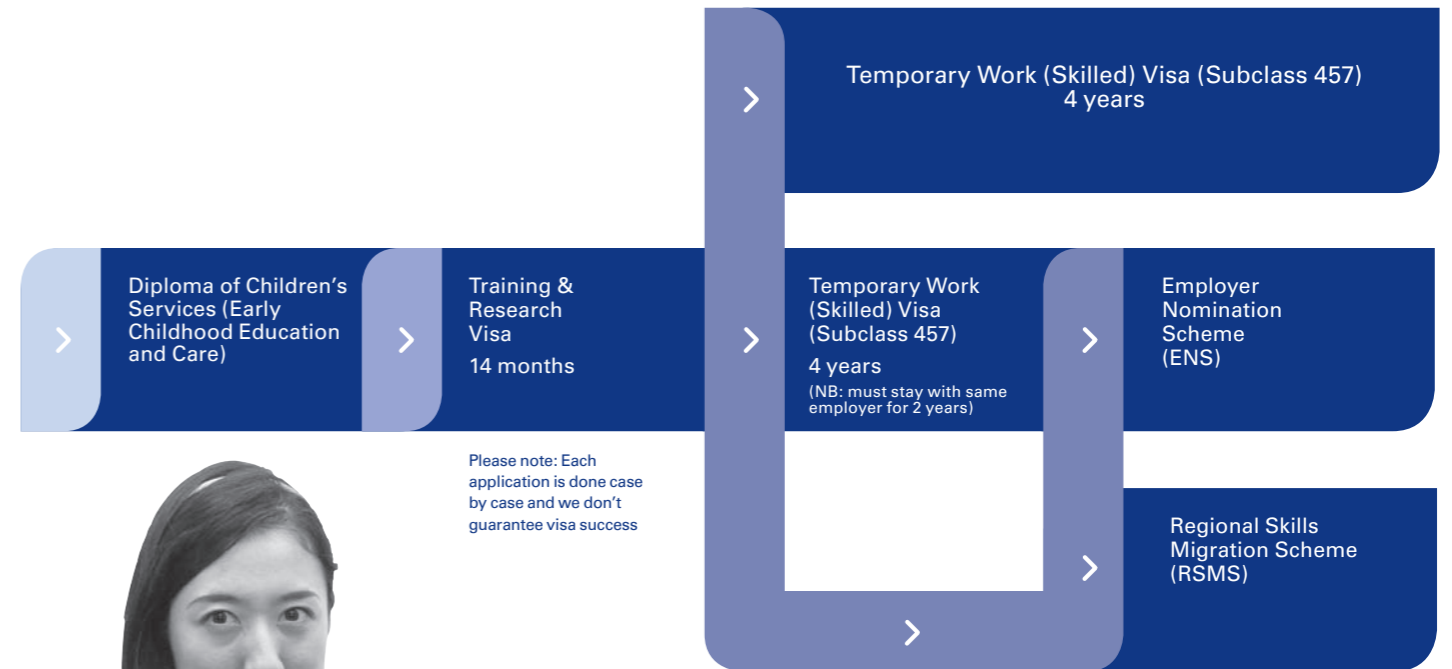
- sponsorship by an approved occupational trainee sponsor (this can be MEGT)
- a nominating employer (a child care centre)
- a letter of support from employer indicating salary
- an individualised training plan based on your work with your employer (we do this with you)
- CV (work history)
- health insurance (travel insurance)
- passport
- must work a minimum of 30 hours per week
- applicants on student visas may apply in Australia but must finish their principal course first
- minimal level of qualification required is a successful completion of a Diploma of Children's Services (Early Education and Care).

### Step by step process

1. Speak with MEGT staff, send your completed CV.
2. Arrange appointment with MMMigration.
3. Pay a deposit of \$500 required.
4. Sign cost agreement and form 956.
5. Make second payment.
6. Receive checklist of documents.
7. MEGT will contact you to arrange an individual training plan.
8. MMMigration will contact you to arrange a meeting to issue application and signed application form.
9. MMMigration lodges the nomination and visa application.
