#### Become an Enrolled Nurse

Enrolled Nurses (EN) are a regulated body of health professionals who contribute to the delivery of healthcare across a variety of Australian healthcare settings and clinical environments, functioning under the supervision of a Registered Nurse (RN). The EN qualification is supported through employability perspectives and managed through an education/training and curriculum approach. Educational preparation for the functional role of the EN in the workforce is as an associate nurse to the RN or Midwife. The HLT54115 Diploma of Nursing is a national entry level qualification for Enrolled Nurses in Australia.

#### **Career Outcomes**

The Diploma of Nursing qualification prepares the graduate for beginning level professional practice as an Enrolled Nurse in the Australian healthcare environment. Focus of educational preparation and graduate outcomes of the course are aligned with the NMBA Standards for Practice: Enrolled Nurses (2016).

## **Entry Requirements**

In accordance with the Australian Nursing and Midwifery Accreditation Council accreditation, the minimum standards for entry into the HLT54115 Diploma of Nursing are:

The applicant must have successfully completed one of the following:

- Year 12 (or equivalent);
- An Australian Certificate III in Individual Support );
- At least two years' experience in a closely related field such as Home and Community Care or Disability
- Mature aged entry (21 years of age or older)
- International students
- Must be 18 years of age prior to clinical placement

All prospective students must attend an information session. Finally, applicants are required to declare their physical and mental fitness to safely perform the duties associated with direct care work.

Academic Entry Requirements for domestic students on VSL:

 A completed Australian secondary education qualification or equivalent; and Undertake Language, Literacy and Numeracy (LLN) testing and demonstrate competency at exit level 3 in the Australian Core Skills Framework (ACSF) in both reading and numeracy

Academic Entry Requirements for International Students: Equivalent IELTS 6.0 (academic) with no skills band less than 6.0

#### Course study requirements

The course delivery covers all theoretical and practical aspects of the Diploma of Nursing.

Students will receive all academic learning materials and will be accessible via the learning portal.

To achieve this qualification, participants are scheduled according to the delivery mode as negotiated.

# Mode 1. <u>College Based at Training Facility</u> (Classroom Delivery)

This program is delivered 3 days each week at a Training Facility, through a combination of the following:

- i. lectures, practical sessions, individual and group activities and Trainer/Assessor moderated discussion on assigned projects.
- Training and assessment is conducted using simulated and real workplace environments. Written tasks and practical tasks/ projects are completed and submitted for assessment.
- iii. The 18 month program includes 400 hours (10 weeks) of full time (Monday-Friday) clinical placement in a range of professional workplace settings. All clinical placement periods are fully facilitated and unpaid.

#### Mode 2. Blended Delivery

Blended delivery method includes a combination of the following:

- Theory delivery on-line through Blackboard, with the student attending classes one (1) day each week on campus
- Practical assessment of competencies in simulated lab setting at specified campuses over one to two week/s at the end of each study block
- iii. Fully facilitated and unpaid clinical placement in a range of professional workplace settings, totalling 400 hours (10 weeks) spaced throughout the 18 month program

Written and practical assignments throughout the course.

Questions - written /oral in class Portfolios/Case Studies prepared from your practical training with clients

Industry placement for client practice work guided by the college

Typically, you will have anywhere from two to four assessments for each Unit of Competency.

# Subject (Unit) Descriptions

The course is comprised of a number of core, elective and general elective subjects. Electives have been chosen based on industry consultation, to ensure students graduate with the necessary skills and knowledge in specialist areas.

# **Units of Study**

# CHCDIV001 Work with diverse people

This unit describes the skills and knowledge required to work respectfully with people from diverse social and cultural groups and situations, including Aboriginal and/or Torres Strait Islander people. This unit applies to all workers.

#### CHCDIV002 Promote Aboriginal and Torres Strait Islander cultural safety

The unit describes the skills and knowledge required to identify Aboriginal and/or Torres Strait Islander cultural safety issues in the workplace, model cultural safety in own work practice, and develop strategies to enhance cultural safety.

This unit applies to people working in a broad range of roles including those involved in direct client service, program planning, development and evaluation contexts.

#### CHCPRP003 Reflect on and improve own professional practice

This unit describes the skills and knowledge required to evaluate and enhance own practice through a process of reflection and ongoing professional development.

This unit applies to workers in all industry sectors who take pro-active responsibility for their own professional development.

The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian/New Zealand standards and industry codes of practice.

#### **HLTAAP002** Confirm physical health status

This unit describes the skills and knowledge required to obtain and interpret information about client health status and to check a client's physical health. It requires a detailed knowledge of anatomy and physiology.

# HLTAAP003 Analyse and respond to client health information

This unit of competency describes the skills and knowledge required to analyse client health information and then to plan appropriate health services within scope of own role. It requires an in-depth knowledge of anatomy and physiology.

#### HLTINF001 Comply with infection prevention and control policies and procedures

This unit describes the skills and knowledge required to follow organisational infection prevention and control procedures, including implementing standard and transmission-based precautions and responding to infection risks.

#### HLTWHS002 Follow safe work practices for direct client care

This unit describes the skills and knowledge required for a worker to participate in safe work practices to ensure their own health and safety, and that of others in work environments that involve caring directly for clients. It has a focus on maintaining safety of the worker, the people being supported and other community members.

This unit applies to all workers who require knowledge of workplace health and safety (WHS) to carry out their own work, in both centre-based and home-based service provision.

#### **HLTENN001** Practice nursing within the Australian health care system

This unit describes the skills and knowledge required to practise as a nursing professional within the Australian health care system, providing health care across the lifespan of people in a range of health and community care services or environments.

#### HLTENN002 Apply communication skills in nursing practice

This unit describes the skills and knowledge required to apply effective communication skills with a person, family or carer and with other healthcare professionals in a variety of health care settings.

Communication skills in nursing practice require using information technology as well as interpersonal skills applied therapeutically in nursing care and small group discussions.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

#### HLTENN003 Perform clinical assessment and contribute to planning nursing care

This unit of competency describes the skills and knowledge required, within the scope of practice, to perform preliminary and ongoing physical health assessments of all body systems, gathering data that contributes to a person's individualised health care plan.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements. The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian/New Zealand standards and industry codes of practice.

#### HLTENN004 Implement, monitor and evaluate nursing care plans

This unit describes the skills and knowledge required to implement nursing care as outlined in a person's plan of care, evaluate outcomes of care provided, record and report progress, and respond to an emergency situation. This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

# HLTENN006 Apply principles of wound management in the clinical environment

This unit describes the skills and knowledge required to apply contemporary wound management principles to the care of various types of wounds. It involves working with the interdisciplinary health care team to contribute to assessment, treatment and ongoing management of a person's wounds.

#### HLTENN008 Apply legal and ethical parameters to nursing practice

This unit describes the skills and knowledge required to within work legal and ethical parameters in professional nursing

practice, including supporting rights and meeting duty of care requirements.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

#### HLTENN009 Implement and monitor care for a person with mental health conditions

This unit describes the skills and knowledge required to contribute to the nursing care and management of a person with a mental health condition.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

## HLTENN009 Implement and monitor care for a person with mental health conditions

This unit describes the skills and knowledge required to contribute to the nursing care and management of a person with a mental health condition.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

#### HLTENN012 Implement and monitor care for a person with chronic health problems

This unit describes the skills and knowledge required to contribute to the care of a person with chronic health problems by performing nursing interventions that support the person's needs and assist them in maintaining an optimal lifestyle. This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

#### HLTENN013 Implement and monitor care of the older person

This unit describes the skills and knowledge required to perform nursing interventions to support the social and emotional wellbeing and nursing care needs of the older person in both acute care settings and residential care environments. This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

# HLTENN015 Apply nursing practice in the primary health care setting

This unit describes the nursing skills and knowledge required to work in a primary health care environment including community-based, educational, occupational and informal settings, and in general practice.

Primary health care involves a person-centred and holistic approach to health care. It is made accessible to people by being located as close as possible to where they live, and supporting their full participation in a spirit of self-reliance and self-determination.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

#### HLTENN010 Apply a palliative approach in nursing practice

This unit describes the skills and knowledge required to provide nursing care using a palliative approach in care environments such as hospitals, home and community care, hospices and long-term care facilities.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

# HLTAID003 Provide first aid

This unit describes the skills and knowledge required to provide a first aid response to a casualty. The unit applies to all workers who may be required to provide a first aid response in a range of situations, including community and workplace settings.

Specific licensing /regulatory requirements relating to this competency, including requirements for refresher training should be obtained from the relevant national/state/territory Work Health and Safety Regulatory Authorities.

## CHCPOL003 Research and apply evidence to practice

This unit describes the skills and knowledge required to establish the information need, gather information and critically analyse the information for relevance to own work.

This unit applies to health and community service workers who need to research existing information to support and improve their work practice. It does not cover primary research.

The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian/New Zealand standards and industry codes of practice.

# HLTENN005 Contribute to nursing of a person with complex needs

This unit of competency describes the skills and knowledge required to provide clinical nursing skills for a person with complex needs and to contribute to complex nursing interventions using critical thinking and problem-solving.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian/New Zealand standards and industry codes of practice.

#### HLTENN011 Implement and monitor care for a person with acute health problems

This unit describes the skills and knowledge required to contribute to the care of the person with an acute health problem by performing clinical nursing skills and interventions that support the person's health care needs and assist them to regain optimal function and lifestyle.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian/New Zealand standards and industry codes of practice.

#### **HLTENN007 Administer and monitor medicines**

This unit describes the skills and knowledge required to administer and monitor medications and intravenous (IV) therapy including calculating dosage requirements, interpreting written instructions from an authorised prescriber, assessing the person for medication effectiveness and side effects, and responding to an allergic pharmacological reaction.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian/New Zealand standards and industry codes of practice

#### HLTENN025 Implement and monitor care for a person with diabetes

This unit describes the skills and knowledge required to provide nursing care to a person with diabetes including assessing needs, planning and implementing complex nursing interventions, evaluating outcomes, and educating the person on his/her condition and available resources.

This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses, and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian/New Zealand standards and industry codes of practice.

#### HLTENN014 Contribute to maternal and infant health care

This unit describes the skills and knowledge required to provide care to mother and newborn infant in a range of health care settings such as postnatal, neonatal, child and family health care and paediatric settings. This unit applies to enrolled nursing work carried out in consultation and collaboration with registered nurses and registered midwives and under supervisory arrangements aligned to the Nursing and Midwifery Board of Australia regulatory authority legislative requirements.

The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian/New Zealand standards and industry codes of practice
