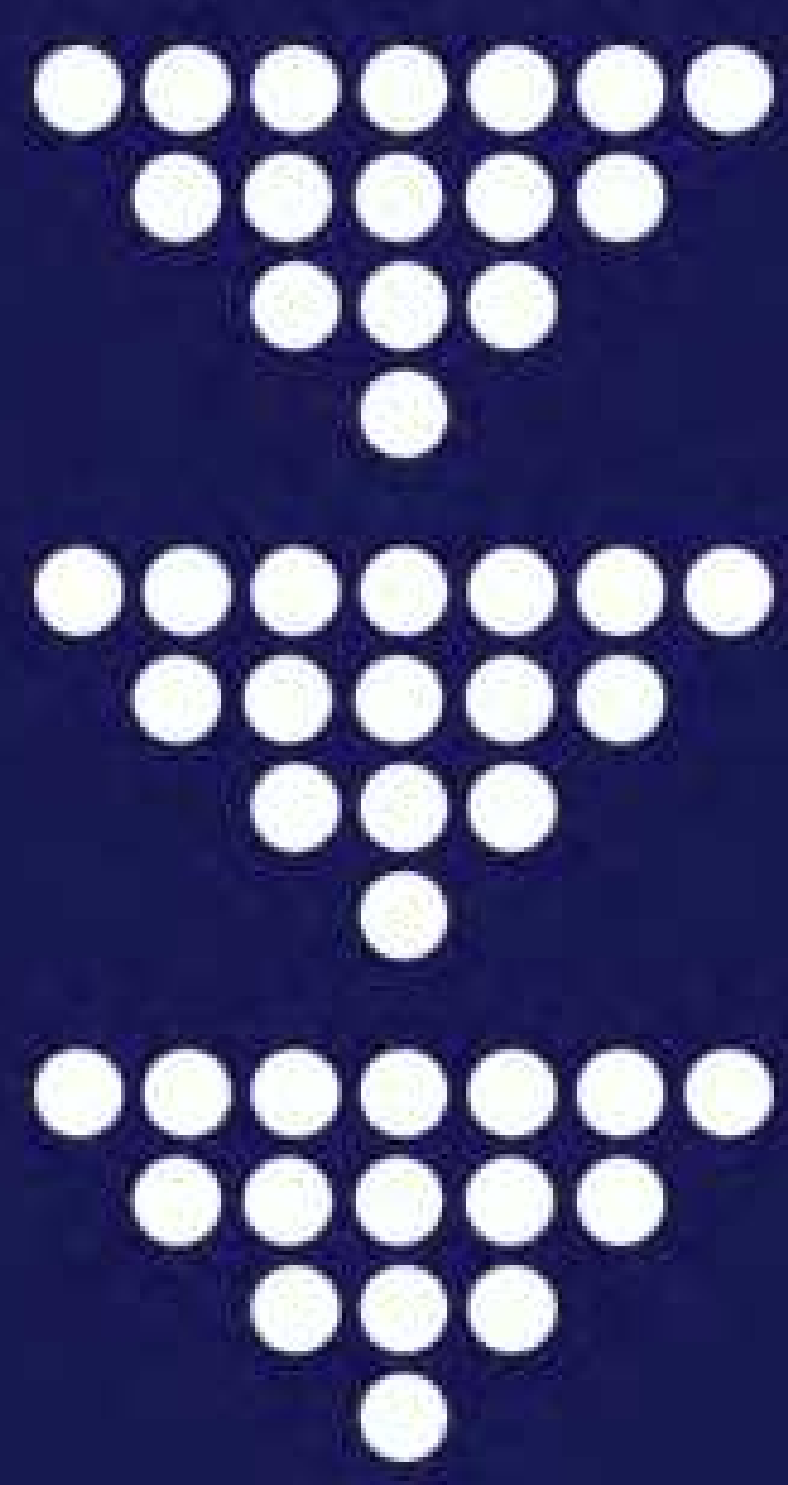

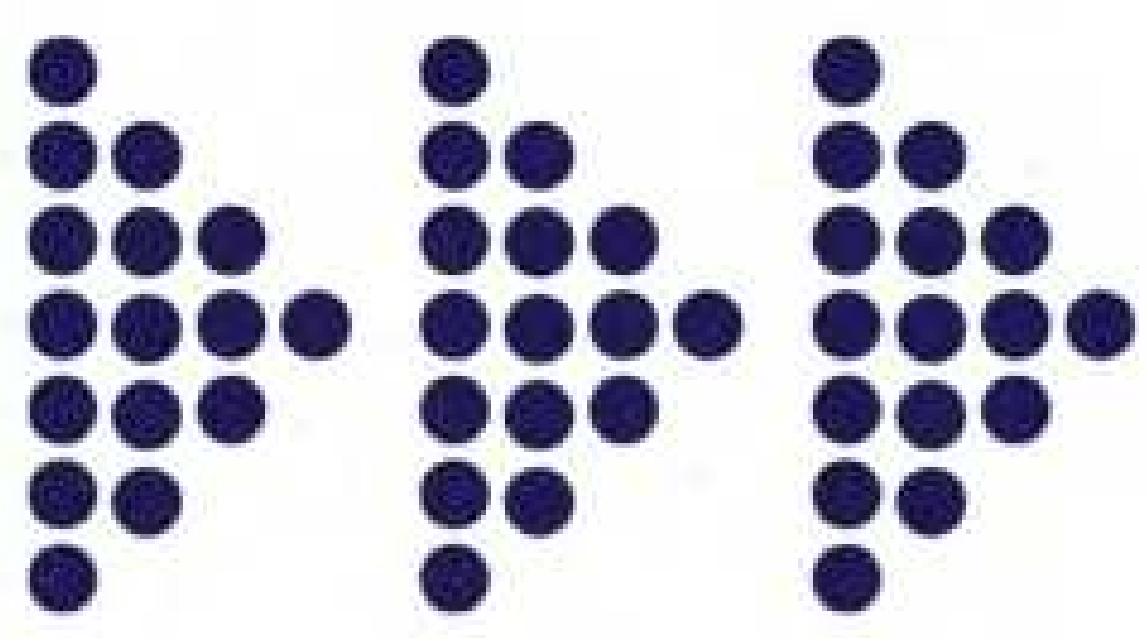

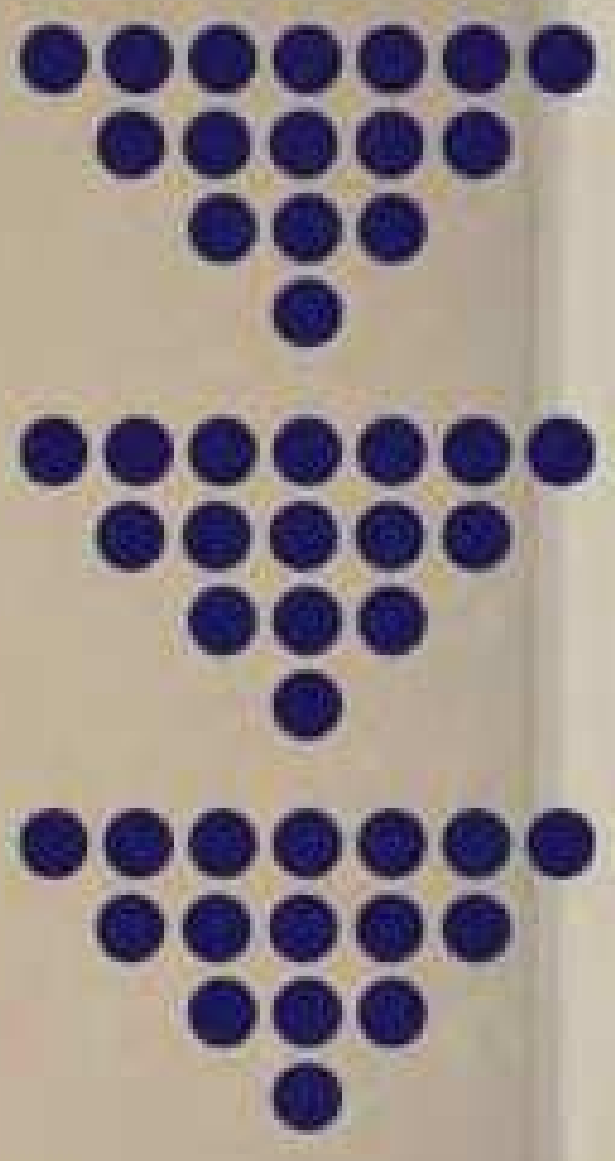

OUR BRIEF HISTORY

In the last 18 years, UPC College has achieved its reputation through quality training and student support. The College acknowledges outstanding contributions from its former academic staff, **Ms Michelle O'Connor-Davis (English)** and **Ms Shelagh Millers (Childcare)**

● **2002**

UPC history goes back to 2002 when a private college was established to provide coaching to local primary and high school students.

● **2004**

By 2004, a group of academics from the University of New South Wales, University of Sydney, and University of Technology Sydney conceived the idea of a high-quality private education institute: UPC Pty Ltd trading as University Preparation College was established.

● **2008**

UPC was one of a small number of quality private colleges chosen by the Australian Government to deliver government-funded training to local students under the Productivity Places Program (PPP) in 2008. By 2012, the Program was transferred to the NSW Government, changed the name to Strategic Skilled Program (SSP) and UPC has continued to win annual contract since then.

● **2012**

On the international scene, UPC has successfully introduced "RPL/Gap Training" to Hong Kong Kindergarten teachers to acquire Certificate III in & Diploma of Early Childhood Education and Care (ECEC) qualifications. The candidates have theoretical training in Hong Kong and arrive in Australia to complete their work placements. This training mode has been ongoing till now.

● **2016**

By 2016, the Transnational delivery of ECEC has been rolled out to Sri Lanka with students finishing the theoretical component of the courses in Colombo and coming to Australia for work placement.

● **2019**

In June 2019, UPC completed its relocation from Bankstown to the new City Campus. By October, its cooperation program with the College of Foreign Economic Relations (COFER – HCM City, Vietnam) showed its first success, and the pandemic has not slowed down its expansion in 2020 and 2021.

● **2020**

The year 2020, marked by the pandemic, witnessed several significant events for UPC. First, UPC became one of the first RTOs to deliver its courses online in April. Second, in November, UPC upgraded all BSB qualifications and added two Graduate Diplomas to its scope from the newly released Business Package. Finally, in December, UPC opened its Melbourne campus.

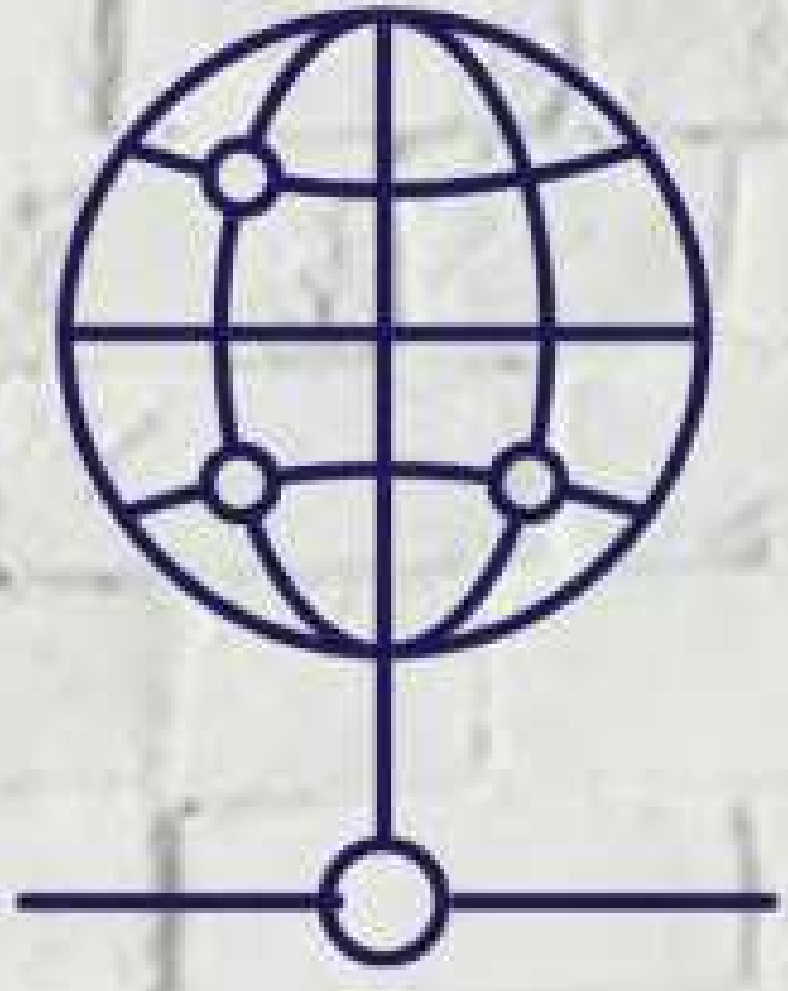
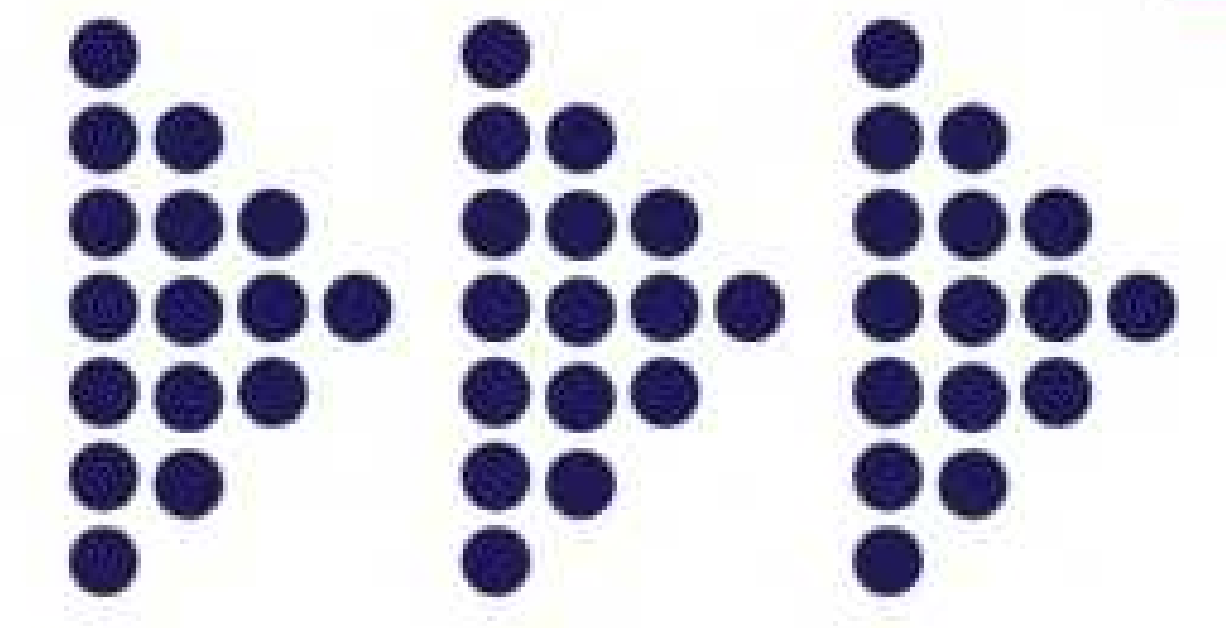
● **2021**

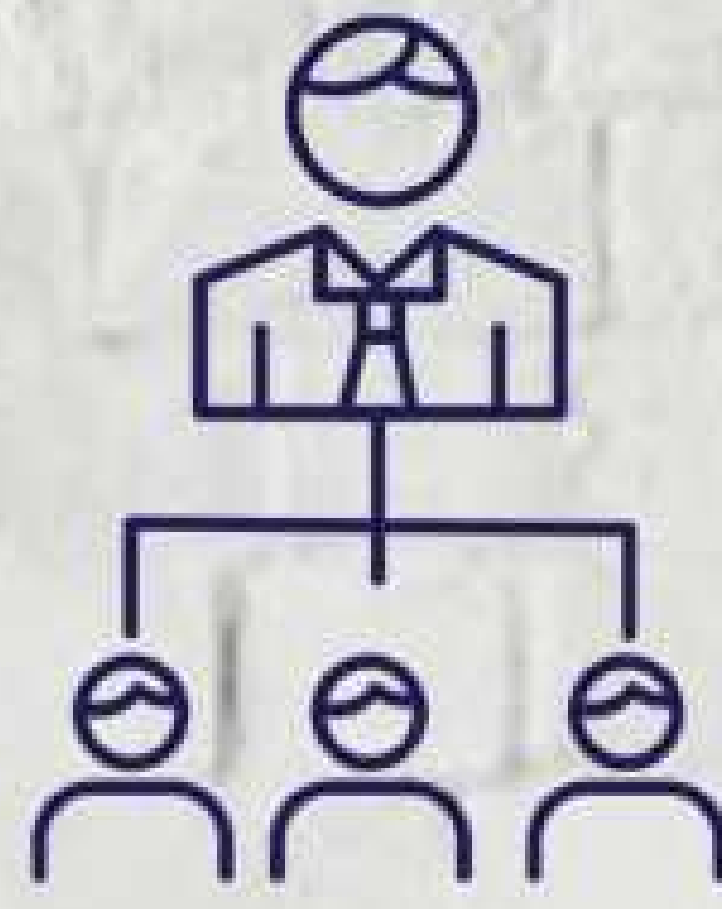
● **2022**

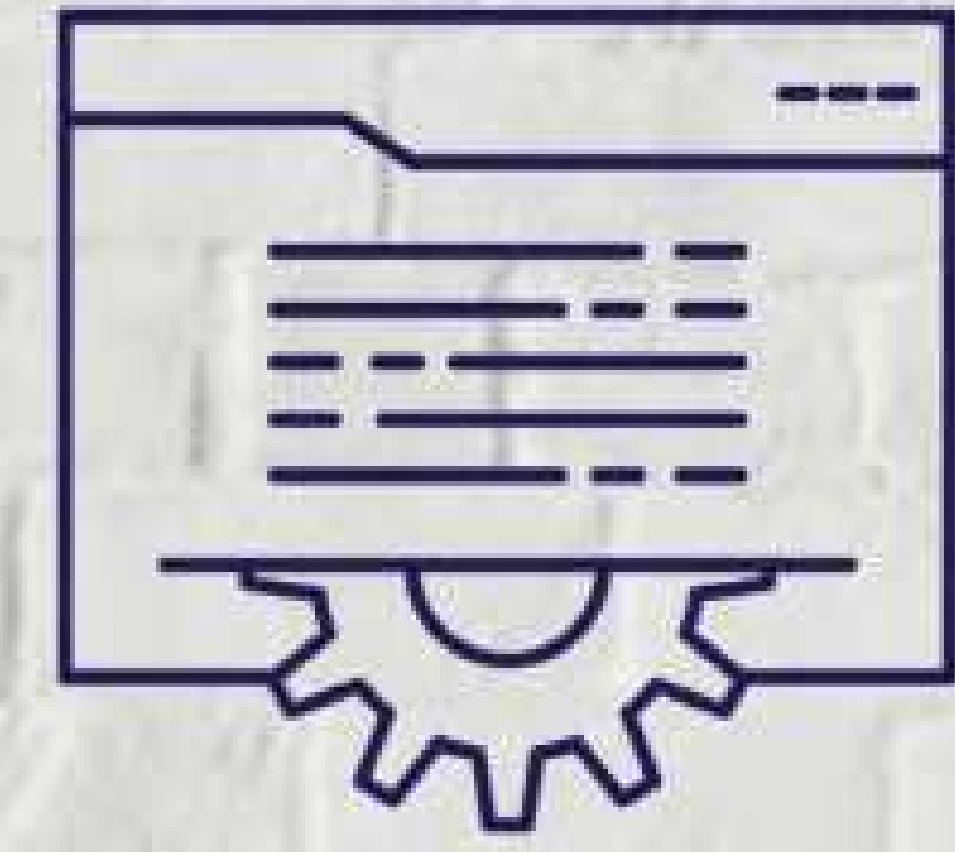

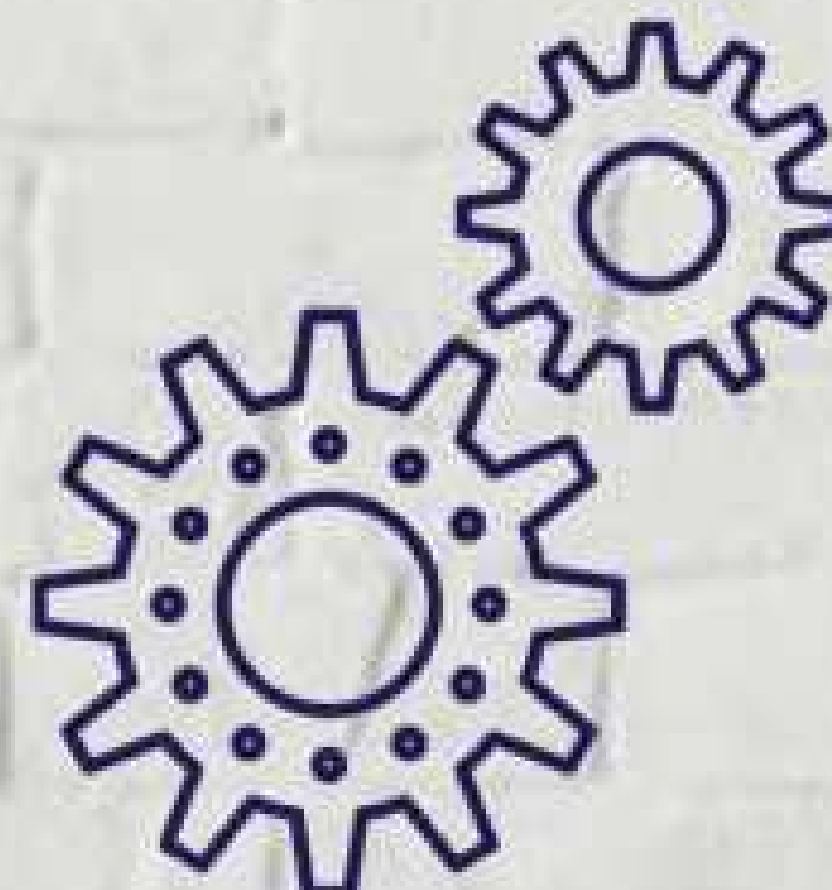
Local students mix with international students. We run government-funded courses for Australian-resident students.



ELICOS courses for international students who need additional English learning for VET or higher education courses.



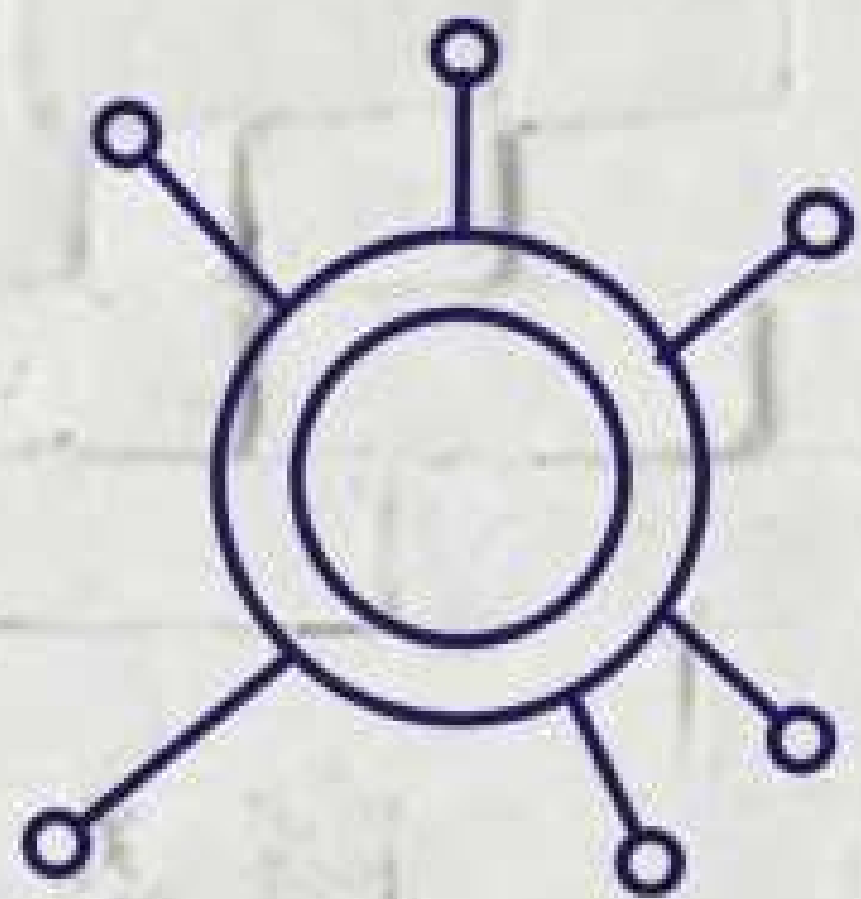
Childcare graduates are eligible for Graduate Work Experience and Occupational Training Program (Conditions apply).



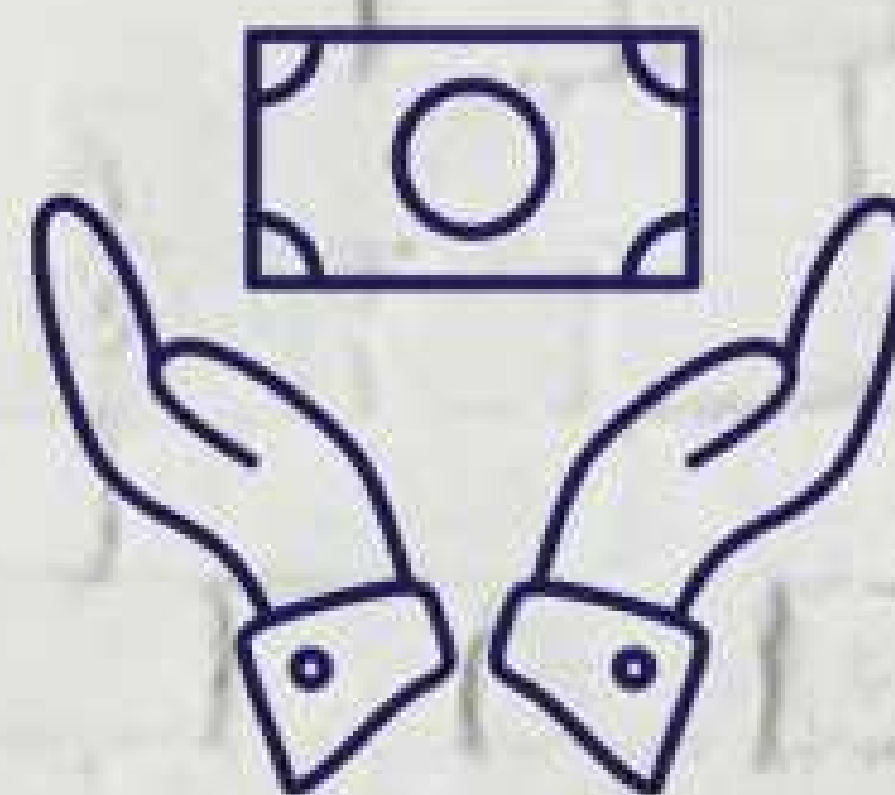

ENGLISH (ELICOS) PROGRAM

Components of the English Program

Our ELICOS (English Language Intensive Course for Overseas Students) program has been developed for international students who require English training to meet English entry requirements by the Australian education providers. Our program has been endorsed by NEAS Australia, approved by ASQA as an official English course for entering into formal VET or university courses, and also recognised by the Australian Department of Home Affairs for the student visa application purpose.

Our ELICOS program includes three courses:

- English for Higher Education Studies;
- English for Academic Purposes; and
- Preparation for IELTS.

English Placement and Proficiency Tests

If you do not have results of an international English test (e.g. IELTS, TOEFL, etc.), you will first sit for UPC online **English Placement Test** to measure your English competence and estimate the time requirement of your English program to reach a certain level for your tertiary education (For visa application purpose). This test is also accepted by a number of Australian education providers as their course entry English test.

On arriving at the College, you will sit for a more comprehensive test (**English Proficiency Test**) to determine your current English level for actual class placement.

Teaching Method

- You progress through each level at your own pace.
- Reading, writing, listening and speaking are based around themes.
- Excursions and study tours introduce Australian culture.
- Topical newspapers, magazines, websites and entertainment are used as resources.
- Every student will build a folder of learning materials and complete assessment tasks.

Assessment Methods

- Writing tasks, short answer questions and quizzes.
- Direct observation in class.
- Oral practice, individually and in groups.
- Oral and written assessment tasks.
- Weekly tests, end of level (Term) examinations.
- Your progress is carefully tracked and recorded in individual records.



Resources Requirements

You can access all course learning, training and assessment materials using our Moodle system. The course material fee for each English level (one term or 10 weeks) is \$50.

Total Volume of Learning and Delivery Mode

Each ELICOS course is divided into different levels, and each level is delivered in a 10-week study period (or term). The total volume of learning of each level is 350 hours which include 180 hours of contact learning, 150 hours of self-study and 20 hours of exam.

We offer a blended delivery mode of classroom learning and structured self-study. During the study period, you attend classes 20 hours per week (four sessions) and spend another 15 hours for self-study.

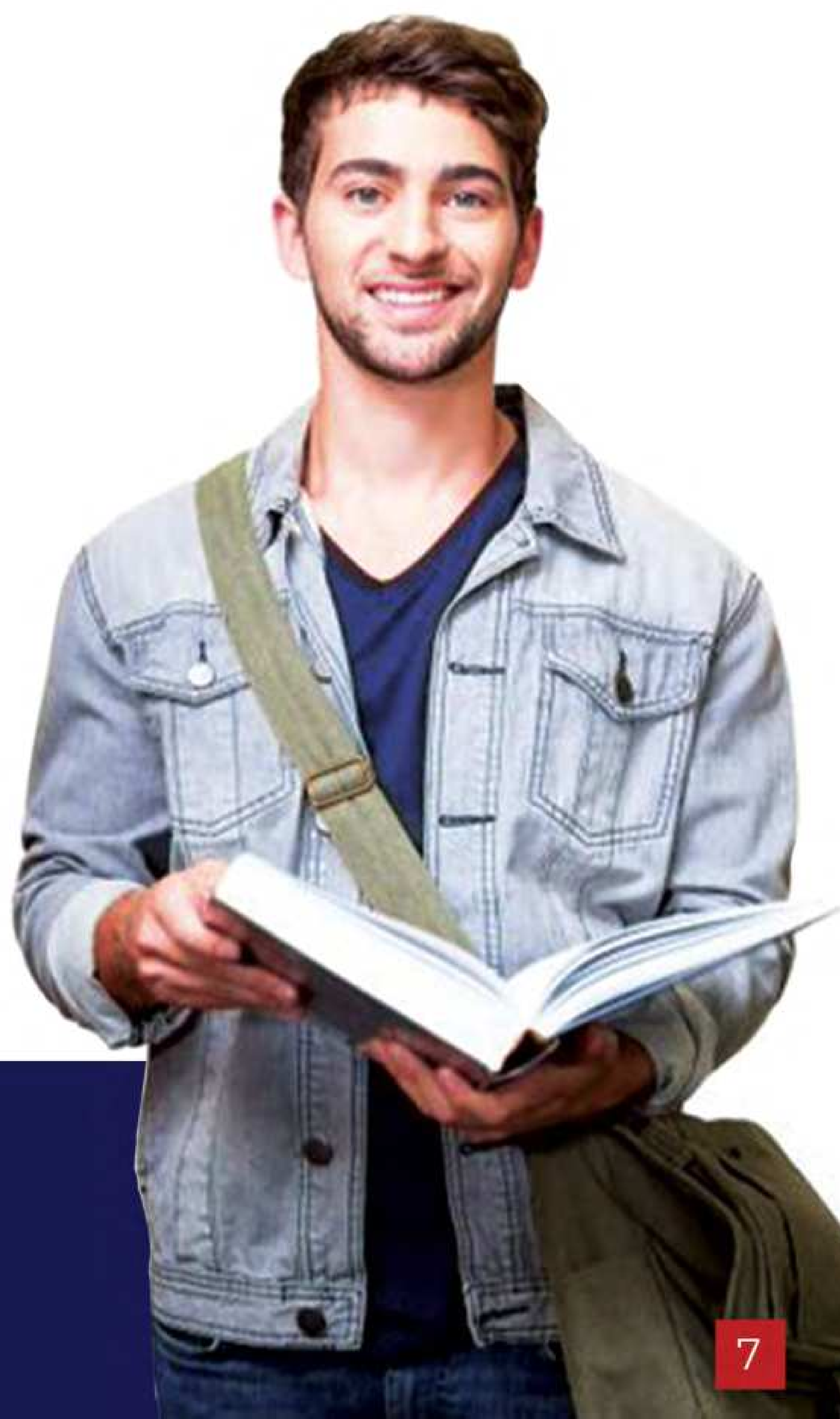
Start date

It is preferred you will commence the program at the start of a term. In practice, you can begin your study on any Monday during the first six weeks of the term.

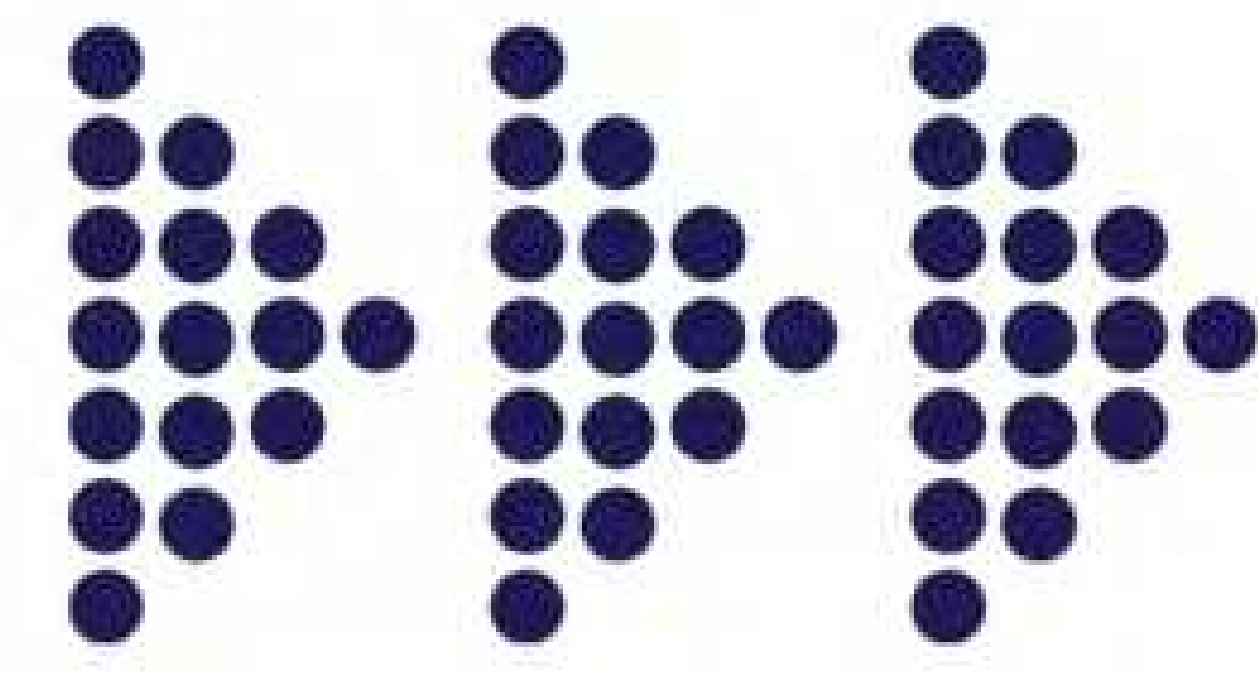
Work Permit during Study Period

You are permitted to have paid employment during your study in Australia: 48 hours per fortnight (every two weeks) during study term and no hour limit during term breaks or holidays.

ENGLISH FOR HIGHER EDUCATION STUDY

Course Description and Program Outcomes

The English for Higher Education Study (EHES) is our flagship English program which provides English training to students who want to maximize their language learning and practice during their preparation for college or university studies. The program aims at providing students with different opportunities, in and out of the classroom, to learn daily English language at the lower levels (Levels 1-4) and move to academic English for higher education study (Level 5).

Your teachers will include various learning activities, inside and outside the classroom, to ensure the highest involvement and interaction of the students. Ultimately, the assessments will demonstrate improvement in your English language skills.

The program has five levels, and their entry and exit levels are presented in the Table 1 while specific skills after completing each level are explained in Table 2.

(4) Intermediate Level

- ✓ deal with more complex communication for problem solving in everyday life

- ✓ read, understand and interpret longer texts

(5) Upper Intermediate or English for Academic Purposes

- ✓ communicate information on the everyday and deal with academic topics abstracts
- ✓ read and understand texts of a more academic nature and deal with more complex abstraction
- ✓ make classroom presentations
- ✓ write short essays and discussion texts

Entry Requirement

Depending on your English proficiency level, you can enter the program at different entry points.

- **Academic:** Completed Year 11 of a 12-year school system.
- **English proficiency:** See Table 1.

Program Outcomes

On successful completion of each level, you will be issued with a Certificate to show your English proficiency level (At skill levels and overall). Your English Certificate will be valid for 2 years. On successful completion of Level 5, your English proficiency will be interpreted as below (Using equivalent IELTS score):

- 5.5 IELTS score (Equivalent) if your grade is between 50% to 84%, or
- 6.0 IELTS score (Equivalent) if your grade is 85% or above.

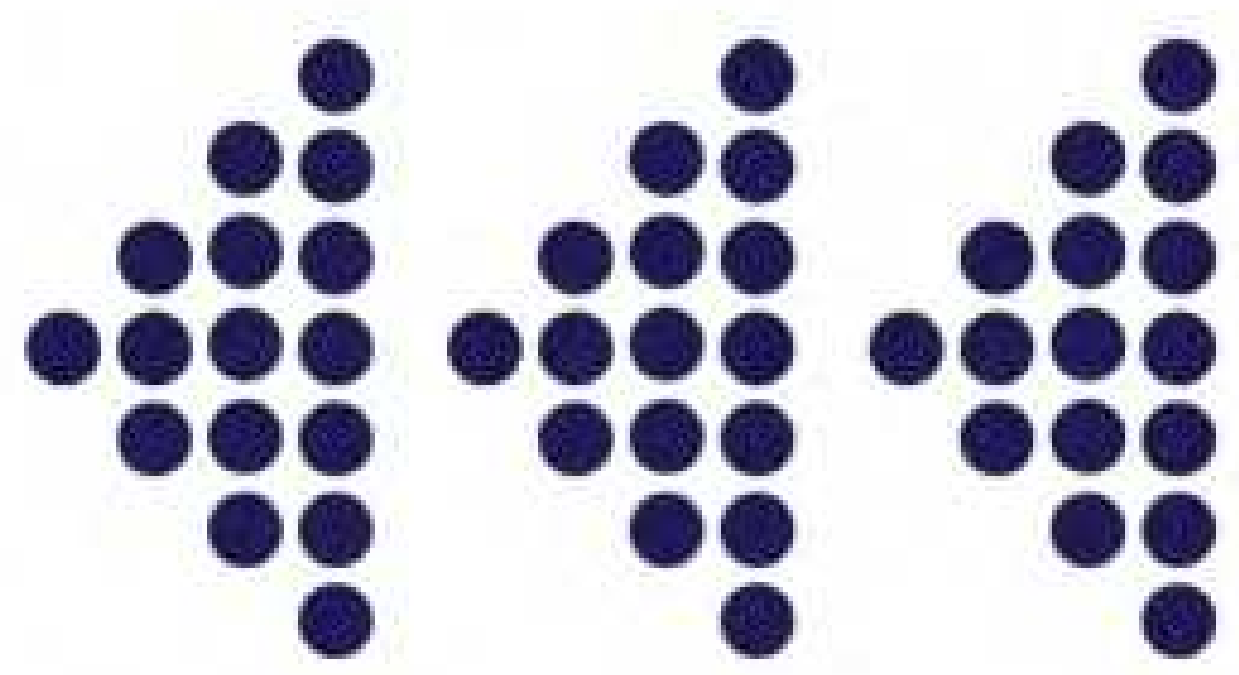

ENGLISH FOR ACADEMIC PURPOSES

Reasoning and Course Description

Whilst you may be academically excellent in your subject area, you may find that lectures, tutorials, homework, essay writing and exams are conducted in a different way from your home country.

The English for Academic Purposes (EAP) will increase your overall grammar, vocabulary and English proficiency. The program will especially allow you to develop language skills, study skills and academic vocabulary used at higher education level in an academic setting. It focuses on skills such as:

- communicating information in everyday situations and dealing with abstract academic topics
- delivering academic presentations and building communication skills in tutorials
- reading and understanding texts of a more academic nature, and dealing with some abstraction
- producing various essay types and written texts
- planning and writing academic reports
- building up high level skills of research, organising, writing, paraphrasing, referencing, and employing technological resources.

There are two levels - EAP 1 (Upper Intermediate) and EAP 2, (Advanced) and it takes 10 study weeks (One term or three calendar months) to complete each level.



Program Outcomes

On successful completion of each level, you will be issued with a Certificate to show your English proficiency level (At skill levels and overall). Your English Certificate will be valid for 2 years.

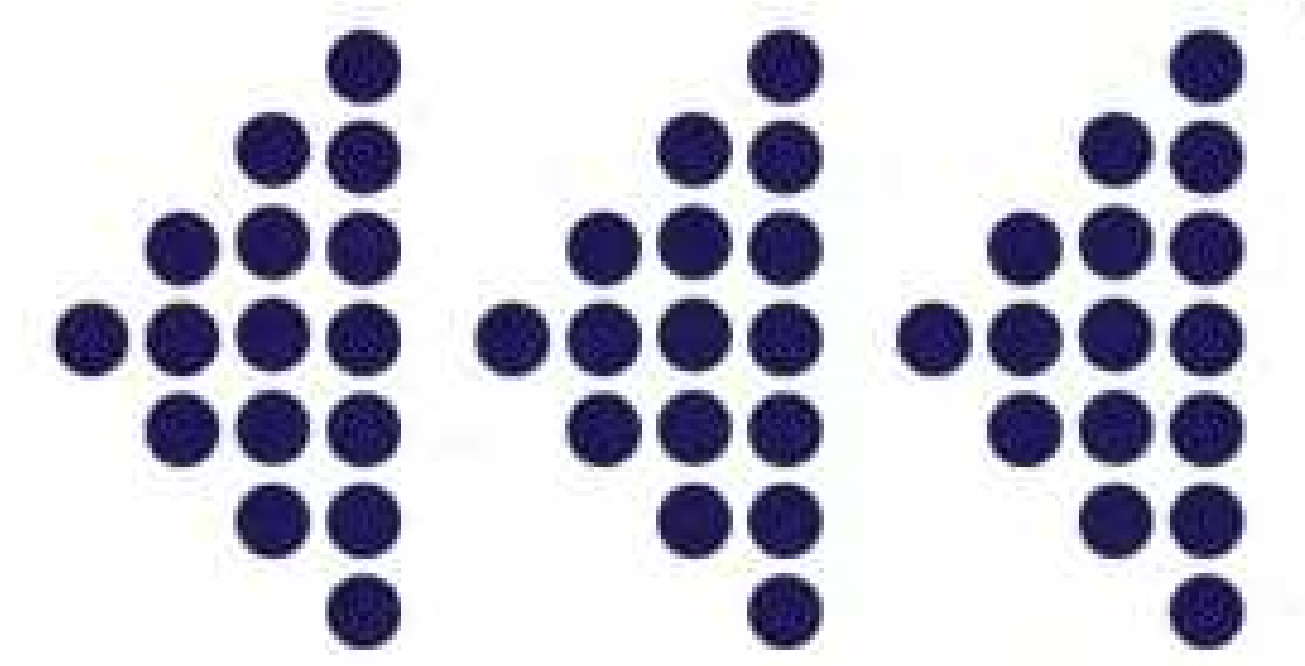
On successful completion of EAP 1, your English proficiency will be interpreted as below (Using equivalent IELTS score):

- 5.5 IELTS score (Equivalent) if your grade is between 50% to 84%, or
- 6.0 IELTS score (Equivalent) if your grade is 85% or above.

On successful completion of EAP 2, your English proficiency will be interpreted as below:

- 6.0 IELTS score (Equivalent) if your grade is between 50% to 84%, or
- 6.5 IELTS score (Equivalent) if your grade is 85% or above.

PREPARATION FOR IELTS

Course Description

This course focuses on preparation for the International English Language Testing System (IELTS) exam.

At this level, the English focus is on reading and listening comprehension, and writing and speaking at a tertiary level of study.

You will learn to:

- contribute with ease to classroom interaction and discussions of an academic nature
- write notes, assignments, essays and rephrase and rework research findings
- read and understand academic texts and interpret examination questions
- make effective classroom presentations and involve colleagues in discussions

We offer intensive IELTS preparation to meet external IELTS examination dates and entry cut-offs for colleges and universities.



Program Outcomes

Depending on individual English requirement, you can enter either Level 1 aiming at an IELTS score of 5.5 (VET course English entry requirement) or Level 2 for IELTS score of 6.0 or over (Higher education course requirement or visa application purposes).



BUSINESS, LEADERSHIP AND MANAGEMENT PROGRAM

Components of the Program

The Business, Leadership and Management Program includes five qualifications (or courses). Depending on your academic achievements and workplace experience, you can enter the program at a suitable point. Similarly, you can exit the program to seek employment, enrol into a bachelor degree, change study field or due to personal situation, without losing recognition of your knowledge and skills you have gained.

- **BSB40120** Certificate IV in Business
- **BSB50420** Diploma of Leadership and Management
- **BSB50620** Diploma of Marketing and Communication
- **BSB60420** Advanced Diploma of Leadership and Management
- **BSB80120** Graduate Diploma of Management (Learning) and
- **BSB80320** Graduate Diploma of Strategic Leadership

Credit Transfer (CT) and Recognition of Prior Learning (RPL)

Credit Transfer or/and Recognition of Prior Learning are available if you have studied business or management courses or worked in business environments. If CT or/and RPL is granted, you may have your studying and visa periods shortened.

English Entry Requirement to a Course (Qualification)

If you do not have results from an international English test such as IELTS, TOEFL, Pearson, etc., the below tests/situations may be used for course admission:

- UPC English Placement Test (Free of charges)
- ELICOS Certificate from an endorsed English centre/college
- Successfully completing the 2-year senior high school or an AQF Certificate III or above, taught in English or
- Coming from an English-speaking country.

Resources Requirements

You can access all course learning, training and assessment materials using our Moodle system. The course material fees for all business and management courses are \$150 per qualification.

Assessment Method

Assessments are competency-based. The theoretical component of each unit is assessed in the form of written assignments, case studies, research projects, etc. while the practical component is assessed in a simulated business environment.

Work Permit during Study Period

You are permitted to have paid employment during your study in Australia: 48 hours per fortnight (Every two weeks) during study term and no hour limit during term breaks or holidays.

Currency - The electronic version of this document posted in UPC website is the approved and most current. Any printed version is uncontrolled and may not be current.

Main Points of the Program

- ✓ **Gaining the qualifications in record time** – The whole program is cleverly designed that you can competently complete it in a reasonable time.
- ✓ **Most affordable tuition fees** – UPC College celebrated its 18th Anniversary in December 2022 and we are proud that the College is a top quality one and the most affordable college in Australia.
- ✓ **Start date** – It is preferred you will commence the program at the start of a term. In practice, you can begin the program any time when a new unit is commenced.

Qualification Description

This qualification reflects the role of individuals in a variety of Business Services job roles. These individuals may have supervisory performance accountabilities.

Individuals in these roles carry out a mix of specialist and moderately complex administrative or operational tasks that require self-development skills. They use well-developed skills and a broad knowledge base to apply solutions to a defined range of unpredictable problems and analyse information from a variety of sources. They may provide leadership and guidance to others with some limited responsibility for the output of others.

Entry requirements

- ⦿ English proficiency: IELTS overall score equals to 5.5 or equivalent (Also see Page 13 for more details)
- ⦿ Academic: Successfully completed year 12 of the 12-year school system. Year 11 students with high achievement will be considered.

Pathway to Further Study

This qualification provides theoretical and practical knowledge and skills for specialised and skilled work or for further learning.

Therefore, after successfully completed this qualification, you may choose to study a Diploma or an Advanced Diploma in a wide range of study fields.

For internal pathway, you will have a credit of 4 units (or 3 months) when you enrol in the BSB50420 Diploma of Leadership and Management.

Course Completion

Delivery Mode and Total Volume of Learning

We offer a mixed mode of delivery: Classroom and structured self-study.

The course has a total volume of learning of 1120 hours which includes 540 hours of contact hours, approximate 400 hours of self-study and 180 hours to complete knowledge and practical assignments.

The course will last 9 calendar months or three 9-week study terms, separated by term breaks. Every week, you will have 14 hours (or two days) in classroom and 6 hours of structured self-study (Following your trainer's instructions). On top of these, you study in your own time approximately 15 hours per week then complete assessments.

Qualification Description

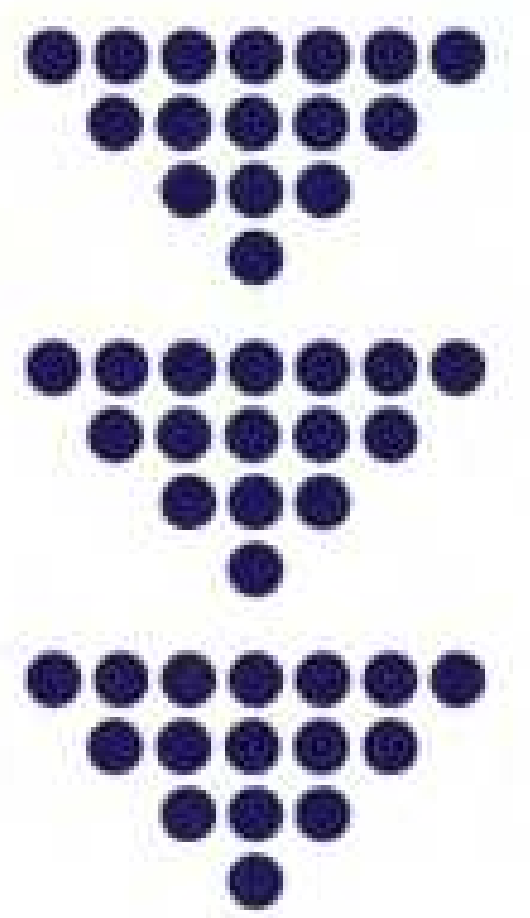


EARLY CHILDHOOD EDUCATION AND CARE PROGRAM

Components of the Program

The Early Childhood Education and Care Program includes two qualifications (or courses). It is mandatory that you should have the Certificate III (Either the recent CHC30113 or the current CHC30121) before you can start the Diploma

- **CHC30121** Certificate III in Early Childhood Education and Care and
- **CHC50121** Diploma of Early Childhood Education and Care.



Credit Transfer (CT) and Recognition of Prior Learning (RPL)

Credit Transfer or/and Recognition of Prior Learning are available if you have studied childcare courses or/and worked in the childcare profession. If CT or/and RPL is granted, you may have your studying and visa periods shortened.

English Entry Requirement to a course (Qualification)

If you do not have results from an international English test such as IELTS, TOEFL, Pearson, etc., the below tests/situations may be used for course admission:

- UPC English Placement Test (Free of charges) or
- ELICOS Certificate from an endorsed English centre/college or
- Successfully completing the 2-year senior high school or an AQF Certificate III or above, taught in English or

Resources Requirements

Terms and Intake Dates

There are four terms (or study periods) per year, and the duration of study within a term is dependent on type of your course:

10 study weeks for ELICOS courses, and

9 study weeks for all VET courses.

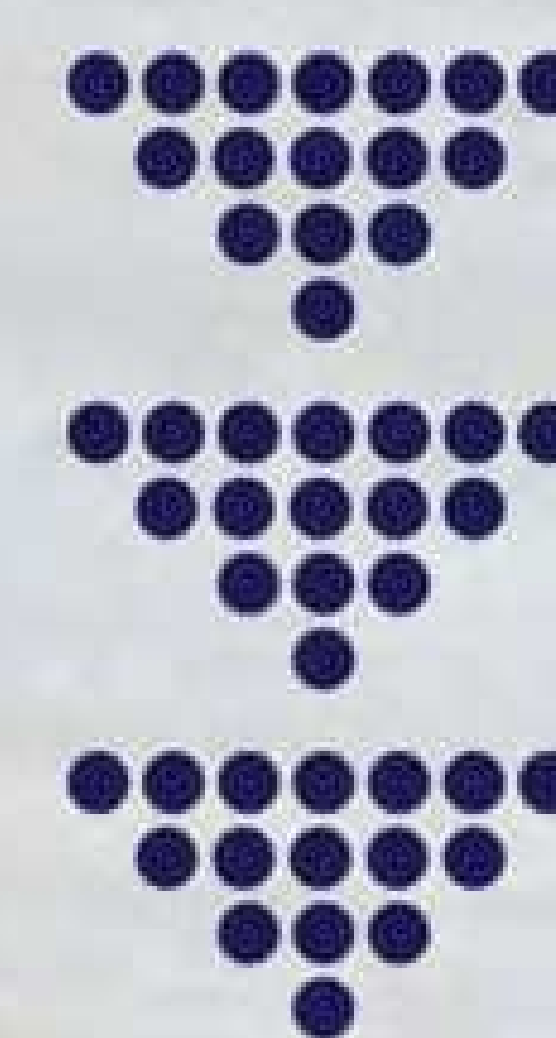

Intake Dates

There are multiple commencement dates for both ELICOS and VET courses, depending on your study plan.

- ➔ ELICOS courses - Six (6) intakes per term (Every Monday of the first 6 weeks the term) and
- ➔ VET courses – One intake per term



Sample Timetables

As an international student, you have to enrol in a full-time CRICOS course. During each study period (or Term), you have to attend a minimum of 20 contact hours per week. There are four types of timetables due to the characteristics of your course.

English class

An ELICOS course has a mandatory minimum of 20 hours face-to-face scheduled course contact per week. You will have to attend classes for 4 days, 5 hours per day and the class will start at 9.00 am and finish at 3.00 pm with 1-hour lunch break.

Business, Leadership and Management Class

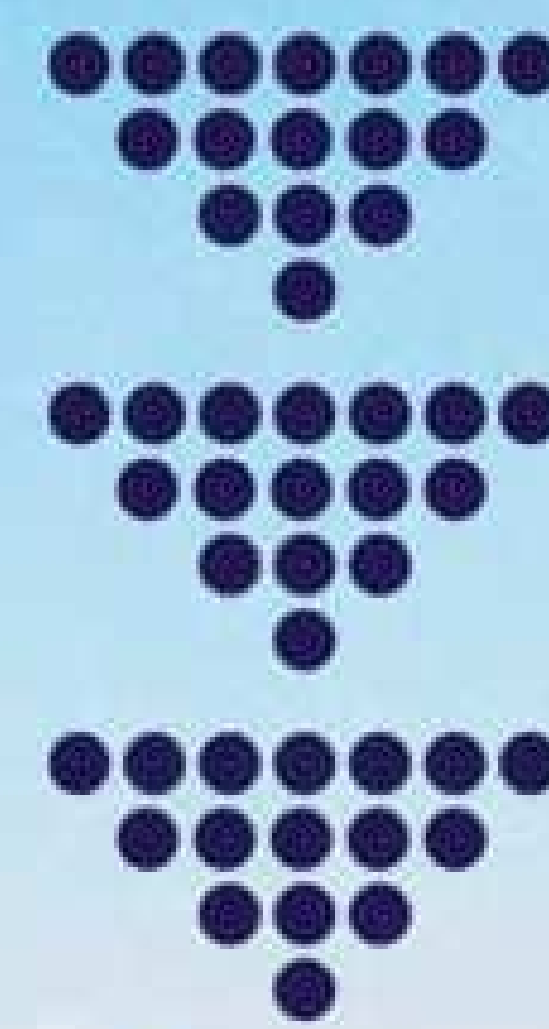
Every week, you will have 14 hours (2 days) in classroom and 6 hours of structured self-study (Following your trainer's instructions). Your class (Days 1 and 2) will start from 9.00 am and finish at 5.00 pm with 1-hour lunch break.

Certificate III in ECEC Class

For the first 7 weeks of each term, you will have 14 hours (2 days) in classroom and 6 hours of structured self-study (Following your trainer's instructions). Your class (Days 1 and 2) will start from 9.00 am and finish at 5.00 pm with 1-hour lunch break. For the last 2 weeks of the term, you will be placed in a regulated childcare centre to carry out the practical component of your course under the supervision of a senior staff there. A UPC assessor will visit you at the centre to assess your practical work.

Diploma of ECEC Class

Every term from week 1-9, you will attend 14 hours (2 days) in classroom and your class (Days 1 and 2) will start from 9.00 am and finish at 5.00 pm with 1-hour lunch break. From Week 3, you will attend your third day at a regulated childcare centre to carry out the practical component of your course under the supervision of a senior staff. A UPC assessor will visit you at the centre to assess your practical work.

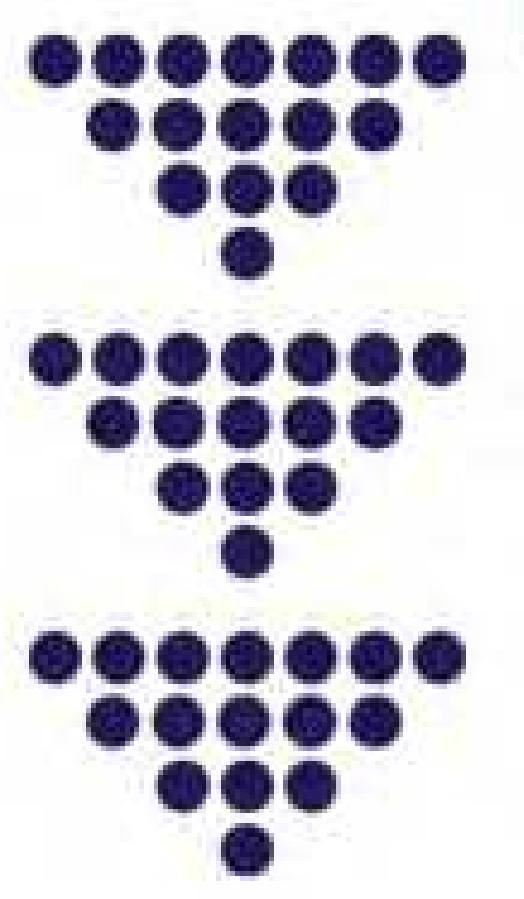
Employability

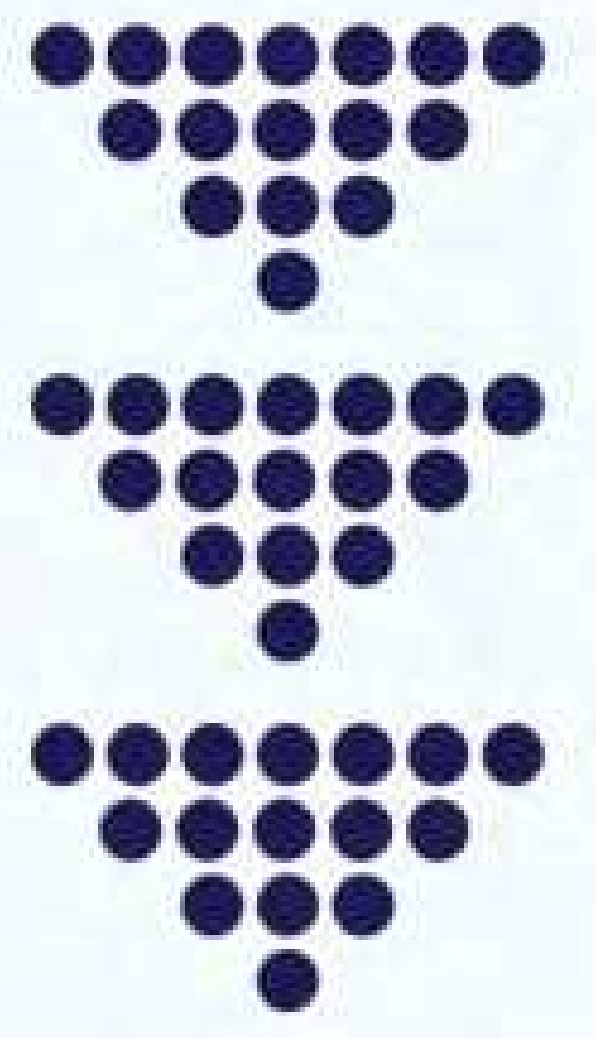
